1. Drug-Free Campus Policy (Short Version)

Objective:

To ensure a safe, healthy, and drug-free learning environment for all students, staff, and visitors, in alignment with the Nasha Mukht Bharat Abhiyan (NMBA).

Scope:

This policy applies to all students, faculty, staff, and visitors within the campus and during all institutional activities.

Policy Highlights:

- **Awareness & Education:** Conduct workshops, campaigns, and orientation programs to prevent substance abuse.
- **Prevention & Enforcement:** Strict prohibition on alcohol, tobacco, and illegal drugs; a Campus Drug-Free Committee will monitor compliance.
- **Counseling & Support:** Provide confidential counseling and referrals to rehabilitation services for affected individuals.
- **Monitoring & Reporting:** Maintain regular audits, an anonymous reporting mechanism, and records of interventions.
- **Collaboration:** Partner with local authorities, health departments, and NGOs to strengthen prevention and rehabilitation efforts.
- **Disciplinary Action:** Violations may result in warnings, counseling, suspension, or legal action per institutional and national regulations.



- Review: Annual review to ensure effectiveness and compliance with NMBA guidelines.

Meeting Schedule


- Quarterly Meetings: Review awareness programs, interventions, and compliance.
